

## Privacy Policy

### Why

The Chamaeleon III light has a wide range of functions that allow it to stand head and shoulders above our competitors' products. One such feature is the Chamaeleon III app which allows the user to adjust the light(s) settings with ease. To access and run this app effectively some personal information is required; this policy aims to provide assurance over enLightens role and responsibilities with your information.

### Overview

This Privacy Policy applies to information which identifies you, or from which you can reasonably be identified. This Policy describes how we handle the personal information we collect when we provide our services via our app. This policy is used to inform visitors regarding our policies with the collection, use, and disclosure of any personal information that may be associated with the running of this app.

If you choose to use our app, then you agree to the collection and use of information in relation to this policy. The Personal Information that we collect is used for providing and improving the service. We will not use or share your information with anyone except as described in this Privacy Policy.

### Information Collection and Use

The information that we request will be retained by us and used as described in this privacy policy.

The app does share a limited amount of data with a third-party service that may access the information used to identify you. The third party operates independently of enLighten and enLighten does not have control over their privacy practices or content. The use of third parties by enLighten is not intended to be an endorsement of the third party, its technology, website, or content.

### Log Data

We collect data and information on your phone called Log Data. This Log Data may include information such as your device Internet Protocol ("IP") address, device name, operating system version, the configuration of the app when utilising our service, the time and date of your use of the Service, and other statistics.

## **Cookies**

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.
